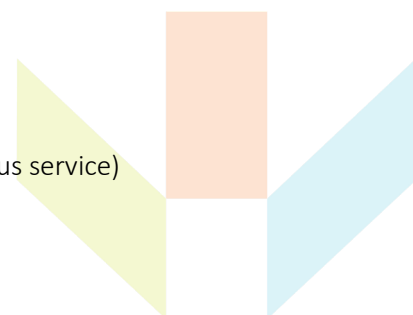
The Opportunity
